



2026-2027 ASSISTANCE SCHOLARSHIP REQUEST

The Leadership Lufkin Alumni Association (LLAA) has proudly established a scholarship fund to assist applicants who demonstrate financial need and require assistance to participate in the Leadership Tomorrow program.

Applicants requesting financial assistance must have made a sincere effort to secure a corporate sponsor before submitting a request. Applicants must submit a written Letter of Request along with their Phase 1 Leadership Tomorrow application. The letter should thoughtfully and thoroughly address each of the following:

- A clear explanation of the applicant's financial need,
- A detailed account of the efforts made to secure a corporate sponsor,
- An explanation of how participation in the Leadership Tomorrow program would personally benefit the applicant,
- A statement outlining why the applicant believes they are a deserving and strong candidate for financial assistance.

Scholarship requests must be submitted by the initial application deadline (May 5, 2026). Requests submitted after the deadline will not be considered.

All financial assistance requests will be reviewed by the Leadership Lufkin Alumni Association Advisory Board. Awards will be determined based on demonstrated need and the number of requests received. Scholarship funds are limited and not guaranteed.

Scholarship recipients will be notified at the time final program selections are announced July 20, 2026.
